Sl. No.	The school is directed to ensure that :
1	Only one CWSN toilet is seen in the IC video. The cubicle and the door of the toilet is very narrow where a wheel chair cannot be entered or navigated. Also the support system is not as per norms, one handle fixed one side of a wall is not sufficient. IC has also suggested that, doorway to the urinal is exactly equal to the width of wheel chair. it must be broader than the chair to facilitate easy movement . Sister has given the undertaking to get the same modification done. Hence the school is directed to construct CWSN toilets for boys and girls with proper infrastructure and submit the compliance on SARAS portal within 3 months with videography.
2	The library is understocked and reading area for students and staff is inadequate. Hence the school is directed to purchase more books to maintain minimum requirement of books in the library as per norms and also upgrade the library as per SoP issued by the Board within 3 months and submit compliance on SARAS.
3	The library is not properly laid out, with work stations and utilities. The school shall upgrade the lab as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
4	The school shall conduct training of its teachers with CoE Bhopal within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.
